Some shared the challenges of living in an old age home; others, the pain of being separated from their loved ones; still others spoke of their school and college days and their busy work life.

After all those memories, they all came back to talk of the harsh, cruel reality of being abandoned to a life of helplessness.

Students had carried essential groceries for the elders' daily requirements and a snack packet which they heartily welcomed and promised to enjoy later that evening. One student confided feeling so good after visiting the old age home; as he was not 'labelled' but simply accepted and loved. This really mattered to most of them.

One elder had a question to a student of ours on being presented the National Flag. "India

Educating the mind without educating the have lost my freedom. Can someone help me get it back?" None of us had a suitable answer to this painful plea we were tongue-tied.
